LAGOS, Nigeria - A Nigerian chef has broken the world record for cooking the largest ever pot of

**Guinness World Records con**firmed the achievement on Monday for the largest jollof rice serving by celebrity chef Hilda Baci.

Baci, who briefly held the world record for the longest cooking marathon in 2023, last Friday prepared a pot of 8,780 kilograms of jollof rice, a popular West African delicacy made from rice cooked in a pepper sauce. The food is a staple across the region.

"It took nine hours of fire, passion, and teamwork," the chef said after the day-long cooking and serving, which involved a moment of high drama when the huge retrofitted pot collapsed under a crane during weighing.

# Former day care worker to serve 6 years

## Every day is a reminder of what happened,' grandfather says

RUSSELLVILLE - A formerRed Bay day care worker will spend six years behind bars in the death of a 4-month-old who had been left alone for up to two hours after the woman placed the infant on her stomach on a "Boppy" pillow.

Payton Nicole Gann wa sentenced Tuesday after being convicted in June of manslaughter in the March 9, 2022, death of Autumn Wells at Tiny Tigers Day Care.

Franklin County Circuit Court Judge Brian P. Hamilton issued a 20-year split sentence with five years to serve

in prison, followed by one year in the Franklin County Jail.

Manslaughter is a Class B felony and carries with it a sentence of 2 to 20 years.

The one-year county jail sentence is for false reporting to law enforcement.

Gann of Golden, Mississippi, pleaded guilty on the first day of her trial. She had claimed Wells was in a swing when the baby died. Testimony during the trial revealed state regulations call for babies under 12 months old to be placed on their back when put down to sleep. There should not be a blanket covering the baby.

Wells' grandfather, Joel Wells, said he hopes this sends a message to day care workers and owners everywhere about

The former employee has not been charged with any crime, and the matter will be referred to the Alabama Attorney General's office for possible prosecution, Dial said. Dial did not release the former employee's name in the statement or during an interview Monday with Alabama Daily

The examiners' office confirmed to ADN that an audit was underway but can't comment until it is released. Dial said that should happen in early October.

Dial told ADN the missing funds probably total \$100,000 to \$200,000. He said the former employee worked for the museum for about two years. The board thought it was saving money by

## Council OKs tax on vape products

MUSCLE SHOALS – A new ordinance that levies a tax on nicotine-based vape products was unanimously approved by the city council on Monday and will go into effect Oct. 1.

After council members voted for unanimous consent, the ordinance was approved following its first reading.

The ordinance allows the city to levy a local excise tax on all vape products sold, distributed, delivered, stored or taken out of storage within the city limits or its police jurisdiction.

According to Alabama Law 2025-377, which becomes effective Oct. 1, the tax is 10 cents per milliliter for businesses

operating inside the city limits, and 5 cents for those operating within the police jurisdiction.

City Clerk Brittany Walker said any county or municipality that does not levy the tax will receive a portion of the state vapor products tax based on a per capita distribution rate
