#### In midst of government shutdown, restaurant customers pay it forward and donate to the food drive to help families relying on curtailed SNAP benefits

## Federal case rife with questions

The plot thickens as key Thao witness suddenly lands in defense crosshairs

# Newsom basks in Prop. 50 victory

Governor urges additional Democratic states to follow suit to counter Trump's moves

Gov. Gavin Newsom's victory lap was brief Election Night after voters overwhelmingly passed Proposition 50, the Democrats' plan to gerrymander the

With a heavily-funded campaign, Newsom and his party's national leaders managed to convince California voters that Proposition 50 was a way to take a stand against President Donald Trump – a president, they said, who is trying to "rig" the 2026 midterm elections by urging similar moves in Republican-led states.

Newsom has used the ballot measure to elevate his national profile and raise millions of dollars in contributions as he plans a possible run for president in 2028.

But in comments to reporters on Tuesday night, Newsom described the ballot measure as just one battle in the national war over redistricting before the midterms. The Republican effort is still in full swing, he said. Officials in GOP-led North Carolina, Missouri and Texas have already redrawn U.S. House of Representatives districts to benefit their party. Newsom called on his Democratic allies in other states to follow suit.

"We need the state of Virginia. We need the state of Maryland. We need our friends in New York and Illinois and Colorado," the governor said. By retaking the House, he said, "we can de facto end Donald Trump's presidency as we know it."

Newsom's political opponents agree on the stakes.

### **Justices seem** skeptical of Trump tariffs

Majority on bench raise questions about his ability to act unilaterally

WASHINGTON — A majority of Supreme Court justices seemed skeptical on Wednesday about President Donald Trump's ability to unilaterally impose far-reaching tariffs, putting at risk a cornerstone of his agenda in the biggest legal test yet of his unprecedented presidency.

Three conservative justices raised questions about whether an emergency law gives Trump near-limitless power to set and change duties on imports, with potentially trillion-dollar implications for the global economy.

The court's three liberal justices also appeared dubious, so at least two conservative votes could limit Trump's tariff power, though likely not end

The case is the first major piece of Trump's agenda to come squarely before the nation's highest court, which he helped shape by naming three of the nine justices in his first term.

The conservative majority has so far been reluctant to check his extraordinary flex of executive power in short-term orders in cases ranging from
