## Supe aims to fix bridge cell service

Hahn asks state to improve signal on Vincent Thomas for suicide hotline

If a person contemplated

jumping off the Vincent Thomas Bridge but was having second thoughts, they couldn't call 988 and speak to a suicide prevention counselor.

That's because the cell Crisis Hotline, 9-8-8, or a family

service doesn't work on the half-mile long bridge that's suspended high above Los Angeles Harbor, pointed out 4th District Los Angeles County Supervisor Janice Hahn.

"I worry about someone standing on the bridge and choosing to call the Suicide

member, only to discover that they don't have the cell signal necessary to make that lifesaving call for help," wrote Hahn in a letter dated Sept. 2 to California Secretary of Transportation Toks Omishakin.

Hahn has asked Omishakin to consider a fix, such as persuading cellular providers to install a cell tower on or near the bridge to extend signal recep-

Federal agency seeks \$77M from Edison for alleged negligence in Eaton, Fairview blazes

The U.S. Department of Justice has filed a pair of lawsuits against Southern California Edison, seeking at least \$77 million in damages and accusing the company of negligence in relation to this year's Eaton fire and the Fairview fire of 2022, authorities said Thursday.

The government is seeking more than \$40 million in damages for the Eaton fire and \$37 million in damages for the Fair-

## Council censures mayor for conduct

Panel says leader able to retain duties and powers

The Arcadia City Council supermajority this week censured Mayor Sharon Kwan, but a last-minute stay by the council allowed Kwan to retain her duties and powers as mayor, pending a further vote from her colleagues, if they deem future conduct unacceptable.

A formal stance of disapproval against Kwan was approved with a 4-0 vote Tuesday night, with Kwan abstaining.

### Giorgio Armani, **Italian fashion** designer, dies

MILAN — Giorgio Armani, the iconic Italian designer who turned the concept of understated elegance into a multibillion-dollar fashion empire, died Thursday, his fashion house confirmed. He was 91.

Armani died at home, "peacefully, surrounded by his loved ones," the fashion house said. "Indefatigable to the end, he worked until his final days, dedicating himself to the company, the collections
