**Conn. sues Trump administration** 

### Joins over 20 other states in attempt to end freeze on federal education funding

HARTFORD — Connecticut has joined more than 20 other states in suing to stop the Trump administration from withholding federal education funding amounting to \$6.8 billion nationwide, state leaders announced Monday. The new lawsuit follows the Trump adminis-

tration's freeze on more than \$50 million in federal education funds for Connecticut, impacting almost every school district across the state and programs like summer school and after-school programs, teacher training and English language instruction.

"School districts, administrators, boards of education, teachers are now looking down the barrel of an unprecedented, draconian, catastrophic cut to funding," Attorney General William Tong said at a press conference in Hartford on Monday afternoon. Schools and education

programs across the country had expected the payouts of already-approved funds on July 1, but U.S. Department of Education officials said on June 30 that those dollars would be blocked as federal officials conduct a review to ensure such grants align with President Trump's priorities.

Tong, along with a coalition of 24 other states, is asking the court to declare the funding freeze unlawful and to block any attempts to withhold or delay the funding.

Altogether, Connecticut stands to lose approximately \$53.6 million in federal education funding for the 2025-26 school year.

"This is big money," Tong said. "To take \$53 million from students, children, parents, educators, learning will do incredible damage to the state of Connecticut."

## Teen killed in crash was 'bright, kindhearted'

Trumbull student was cousin of James McGrath

Mason Murren, a 15-year-old Trumbull student, brought joy to those around him, according to a campaign for his family.

Murren died after suffering severe injuries in a crash Thursday night involving an electronic bicycle in Trumbull.

"Mason was a bright, kindhearted boy with a sharp wit, quiet strength, and a sense of humor that brought joy to those around him," an organizer wrote in a Meal Train campaign for his family. "He was deeply loved by those who knew him and will be missed beyond words."

Murren was the cousin of James McGrath, who was stabbed and killed at the age of 17 in May 2022. A jury found Raul Valle not guilty in his murder, though prosecutors said last week they intended to file lesser charges against Valle, on which the jury could not reach at trial. In the wake of McGrath's death, his parents created the Jimmy McGrath Foundation to honor his legacy by raising money for causes associated with youth wellness and violence prevention. # Manos: 'I feel that I can do this'

Stratford Democrat who ran Pepin's restaurant announces mayoral bid

STRATFORD — Linda Manos, the vice chair of the town zoning commission and the past owner of the now-closed Pepin's restaurant, is throwing her hat in the ring to be Stratford's next mayor.

Manos is seeking the Democratic Party nomination and is hoping the Town Committee will throw their support behind her upstart campaign at its endorsement meeting on Thursday. Manos told the Connecticut Post that she is running to spur local economic growth by slashing taxes on residents and by partnering with business leaders to incentivize new construction projects.

"I will do whatever I have to do to make this town better and ensure people can stay here," Manos, a lifelong Stratford resident, said. "I will stabilize the taxes and bring in economic development."

# Inmate gets 40 years in prison in death of cellmate

> BRIDGEPORT — A Bridgeport man who pleaded guilty to strangling his cellmate at the Bridgeport Correctional Center last year while awaiting trial on robbery and sexual assault charges was sentenced Tuesday to serve 40 years in prison.

> Cecil Mills, 36, pleaded guilty in April before state Superior Court Judge Tracy Lee Dayton to murder in the May 26, 2024, death of 43-year-old Steven Bailey, of New Haven. He also pleaded guilty to third-degree



robbery in connection with a Feb. 24, 2024, incident for which he was being held when he killed Bailey, as well as several other incidents. A plea deal in
