YNHH looks to settle data breach suit

Health system includes Bridgeport Hospital

Connecticut's largest health care system has agreed to settle a federal lawsuit over a data breach that exposed the personal information of about 5.6 million people, according to a recent court fil-

Yale New Haven Health Services Corp. and 19 plaintiffs in the class-action

suit filed a joint motion to stay proceedings in U.S District Court this week to allow parties to finalize the settlement over the next month.

Hackers breached the corporation's computer system in early March, exposing personal information of 5,556,702 people, according to Yale New Haven Health. Chief Compliance and Privacy Officer Sherry Coomes detailed the hacking incident in a letter to affected

"On March 8, 2025, we identified unusual activity affecting our information technology (IT) systems," Coomes wrote. "We immediately took steps to contain the incident and began an investigation."

The day of the attack, the hackers copied data on patients, including names, birth dates, addresses, telephone numbers, email addresses, race or ethnicity and medical record numbers. Coomes wrote that Social Security numbers, financial records and medical information were not involved in the breach.

"The sophistication of the attack leads us to believe that it was executed by an individual or group who has a pattern of these types of incidents. We are working with law enforcement as they investigate further," Yale New Haven Health spokesperson Dana Marnane said.

The initial federal complaint by lead plaintiff Jon Nathanson said he and other former and current patients entrusted Yale New Haven Health with sensitive, private information that the system



Video surveillance of ballot boxes begins

Bridgeport's history of voting irregularities, including multiple cases of absentee ballot fraud dating back to the 1980s, will translate to mandatory video monitoring of ballot boxes in all 169 Connecticut towns and cities. And the costs are

modest, for those municipalities that do not already have video surveillance of their drop boxes. According to the current draft of a regulation that was posted Monday and is likely to win approval by the state attorney general over the next few weeks, costs are estimated at about \$3,500 for the

equipment, \$1,500 for installation and the \$1,500 for the fivemonth-long storage of data that will be open for public inspection.

While the law was put into motion by the General Assembly last year, following a chain of alleged fraud and arrests of campaign workers in Bridgeport's mayoral primaries in 2019 as well as the primaries and general election last year and in 2023, it didn't take effect until July 1. Leaders of the Connecticut Town Clerks Association said that many communities already take video of their municipal buildings for overall security reasons and that
