Cardinal crushers

Defending Class LL state champ Greenwich returns all 3 havoc-wreaking linebackers

GREENWICH — Three of the fiercest tacklers in Connecticut high school football are back for another run at a state title. After anchoring a defense that surrendered fewer than 10 points a game. racking up 347 tackles and 11 sacks, all while powering their team to a CIAC championship, the trio of linebackers return this fall hungry to dominate again and prove last year was just the beginning.

The unit that will play in the middle of Class LL champion Greenwich's 4-3 defense consists of seniors Santi Parra and Jack Kelly and junior Justin Carroll, all three of whom started for the Cardinals staunch defense last season, leading them to the school's 10th CIAC championship.

What was it 330-something tackles they had last year? They were all over the place," Greenwich coach Anthony Morello said of his trio, who are all 5-foot-10, with Kelly at 185 pounds, Carroll 200 and

Parra 210. "To have that kind of strength in the middle part of our defense is something we are really excited about. All three linebackers are explosive, love the sport, care about the sport and love their teammates and this culture."

12-unit Greenwich Ave. condo plan OK'd, 6 years, 5 versions later

GREENWICH — After years of deliberations and debate beginning in 2019, plans for new construction at the Bank of America lot off 240 Greenwich Ave. have been approved by the Planning & Zoning Commission.


The proposal for a new residential building, J Lofts on West Elm, will create 12 units of condominiums in three stories and preserve the old bank building facing Greenwich Avenue. Earlier plans by developer John Fareri proposed a 40-unit, four-story plan in the drive-through lot behind the bank, and an earlier version with 60 units and six sto-

The approved plan also calls for the addition of 2,500 square feet of office space in the existing bank building on a new level in-

"I think we're creating something appropriate for the site," said the attorney representing the developers, John Tesei, "It's been a long, collaborative effort on everyone's part."

The development team came in with a new design for the structure in recent weeks, which removed a number of decorative arches from the structure that
