## FBI agent: Diamantis lied in interviews

BRIDGEPORT - A veteran FBI agent Wednesday testified to a list of alleged lies that she and another agent were told by Konstantinos "Kosta" Diamantis in the months leading up to his 2024 arrest on charges of bribery, extortion and other felonies.

Special Agent Jennifer Wagner, the government's final witness before defense attorney Norman

Pattis presents Diamantis' case, said she and another agent met Diamantis in his Farmington home in August 2023, then again in September in a Bristol coffee shop. On both occasions, Diamantis denied helping funnel work to a woman-owned construction administrator.

"She got it on her own," Diamantis said of Antonietta D. Roy, whose company, Construction Advocacy Professionals, won an emergency contract to

oversee construction of a Tolland elementary school in 2019, as well as a similar oversight role in a Hartford high school project.

Roy previously had detailed about \$4,500 \$3,000 in checks and \$1,500 in cash - among four payments to Diamantis. She also said she hired Diamantis' daughter, Anastasia, to a \$45-per-hour part-time administrative job and gave her thousands of dollars in bonuses before firing her as soon as Gov. Ned Lamont fired Kosta Diamantis about four years ago under the shadow of the federal investigation.

"I didn't order her and I didn't encourage her," to hire Anastasia Diamantis, Kosta Diamantis said in an interview that was recorded at a Starbucks in Bristol and played for the jury Wednesday. The 69-yearold defendant represented Bristol for 14 years in the General Assembly before getting a job in the state Diamantis continues on A6

### **Schools** in state improving but not fast enough to hit target

FARMINGTON — Jacqueline "Mimi" Torres-Garcia was a slight girl who used to struggle to throw heavy loads of garbage into the dumpster, a resident of a

condo complex where she used to live says.

Little did Russell Erickson know that the girl's difficulties taking out the trash paled in comparison to the other horrors she endured: Police say the 12year-old suffered prolonged

abuse and malnourishment, was killed and placed in a plastic storage container in the basement of the family's Farmington home before they moved to New Britain, where her remains were found behind an abandoned
