# Vaccination rates vary by school

As Connecticut families prepare for the back-to-school season, many are making sure their children are up to date on the vaccines required for in-person attendance.

While many school districts across the country have seen a decrease in vaccination rates, Connecticut rates as a whole

have seen a rise in recent years. However, a closer look at im-

munization and exemption data shows a more complicated pic-

Every school in the state of Connecticut, whether public or private, is subject to the same vaccination requirements - but the state data shows variations in immunization rates between districts, schools and grade lev-

Vaccination rates don't just

differ between kindergartners and seventh graders - two grades which require specific vaccines to be update by. The rates can also look dramatically different from one school to another. In fact, while many Connecticut schools report 100% or just under that threshold, othshow exemption levels reaching as high as 28%, according to statewide data.

## **Ex-GOP** official fined over absentee **ballots**

The State Elections Enforcement Commission has fined a former chairman of the East Haven Republican Town Committee \$3,500 for the illegal possession of nine absentee ballots he admitted delivering to local election officials during a local 2019 GOP primary.

Carl J. Ruggerio Sr. signed a consent agreement and paid the fine to the SEEC for the nearly 6-year-old case that was closed this week by the commission during its regular meeting.

"I made a mistake," the 89year-old former local Republican leader said in a phone interview on Friday. "Somebody asked me if I would bring some ballots over, and stupid me, I did." Then-Town Clerk Stacy Gravino referred the matter to the SEEC. Ruggerio recalled that at the time that the clerk's office
