CT Insider investigation spurs Blumenthal chatbot protections bill

Sen. Richard Blumenthal, D-Conn., is crossing the aisle to join with Republican Sen. Josh Hawley, R-Mo, this past week to announce bipartisan legislation that aims to protect children from AI chatbots.

The bill is aimed at the tech companies that have created AI chatbot companion services, apps and

websites that allow users to have emotional relationships with AI chatbots on the other side of a text message exchange.

A CT Insider investigation earlier this year found that students in Connecticut were 'dating' AI chatbot companions, and that the companies behind the chatbots were targeting kids with advertising and pushing sexually explicit conversations to minor users.

"I'm using the article as 'Exhibit A' in this effort to elevate the issue," Blumenthal said in an interview this past week. "Connecticut is front and center in this."

The bill would require that the tech companies that make AI chatbots institute periodic age verification processes, require that the chatbots disclose that they are not human and prohibit any minor use of AI companion

chatbots. Making chatbots that promote self harm, suicide or sexual violence would be made a criminal offense.

Failure to adhere to these guidelines could be punishable for up to \$100,000 in civil penalties per offense, the bill out-

CT Insider reported in May that middle school students in Fairfield and Ellington were having romantic or sexual relationships with AI chatbots. In a Fairfield middle school, a group of middle school girls were using an app called Talkie AI to have romantic relationships with chatbots they called "AI boyfriends."

CT Insider tested chatbots on the services Character.ai, Chai AI, Takie, Polybuzz and Replika and found that all engaged in explicit content with users who identified as middle school aged.

"The research and reporting in that article has provided a powerful impetus for reform," Blumenthal said. "The article was a galvanizing force and continues to be a factual part of our case for this kind of legislation.

Tong said definitive word on the resumption of SNAP benefits was imminent because the the administration of President Donald Trump was under

a deadline by the close of business Monday to tell two federal judges whether it will partially or fully fund SNAP benefits, including a legal challenge that a coalition of 21 other attorneys general including Tong and three governors brought in Massachusetts.

At that time, Tong said the question was whether the Trump administration will use a \$5 billion contingency fund to provide reduced SNAP benefits for November or fully fund the program using both contingency funds and additional available funds.


