Police probe ongoing in death of CSU professor

The Columbus Police Department still is investigating the death of a Columbus State University professor who was shot in a residence near Lakebottom earlier this week, CPD said Thursday.

Muscogee County Coroner Buddy Bryan said the shooting of 31-year-old Erica Anderson in the 1600 block of 17th Avenue was accidental. Bryan said Anderson was shot by her roommate, who mistook her for an intruder.

But with the case still under

investigation, CPD Public Information Officer Brittany Santiago told the Ledger-Enquirer in an email Thursday the department can't comment yet on whether there will be charges. Santiago also did not comment further on how the shooter knew Anderson, and did not respond to questions about the accidental classification prior to publication.

"Additional information, including any potential charges

or relationships involved, will be released at a later time once it is appropriate to do so," Santiago said.

Bryan said Anderson's body will be sent to the Georgia Bureau of Investigation for an autopsy.

CSU officials have expressed sorrow after Anderson's death, with CSU President Stuart Rayfield telling the Ledger-Enquirer Monday that the university was "deeply saddened" by the incident.

Anderson was new to the faculty this semester, Rayfield

said. She joined the CSU Department of Theatre and Dance as a lecturer in costume and was the costume shop supervisor, she said.

"While we mourn her passing,

John Bolton indicted over handling of classified information

John R. Bolton, the national security hawk and former adviser to President Donald Trump who became one of his most outspoken critics, was indicted by a federal grand jury in Maryland on Thursday on charges of mishandling classified information.

An 18-count indictment accused Bolton of using an email account to send "diary" notes about his day-to-day activities as Trump's national security adviser in 2018 and 2019. Many of those notes included "national defense information," including details classified as top secret, the indictment charged.

Those emails were later hacked by someone associated

with the government of Iran, the indictment said.

While Bolton is part of a string of perceived enemies of the president to become prosecutorial targets, the federal investigation into him gained

School gives players chance to revive football season

The Columbus middle school that canceled the rest of its football schedule has given its players a chance to revive their season.

Double Churches Middle School canceled its remaining football games this year "due to the team's disciplinary matters that have resulted in an insufficient number of eligible players," Muscogee County School District communications director Kimberly Wright told the Ledger-Enquirer in an email Tuesday.

Wednesday, in another email to the L-E, Wright confirmed DCMS principal Michael Seckinger sent a message to the players' parents explaining how the players could atone.

"The principal is working closely with district administration and athletic leadership to explore restorative actions that could allow the season to resume," Wright said. "It's too early to determine any outcomes at this moment."
