Jury: Man guilty of felony murder in death of Renee Eldridge

A Muscogee County jury in the trial of a man who faced charges including felony murder and rape in the death of a Columbus woman a decade ago has reached a verdict.

Stacey Gray, 55, stood trial during the past two weeks in the death of 25-year-old Renee Eldridge, whose body was found July 7, 2015 in Osanippa Creek in Chambers County, Alabama.

Gray faced charges of malice murder, two counts of felony murder, aggravated assault, kidnapping and rape, according to the bill of indictment.

The jury found Gray guilty of one count of felony murder. aggravated assault and rape.

that for the family." Kelly said Gray will face a sentence of life in prison with or without the possibility of parole

TSA offers \$45 option for those without REAL ID or passport

The Transportation Security Administration announced Monday that fliers who don't have an acceptable REAL ID or passport can pay a \$45 fee and use Confirm.ID, a modernized identity verification system to confirm their identities at secu-

rity checkpoints starting Feb. 1. Those without the proper identification will be sent to TSA's optional Confirm.ID process before entering the security line, the TSA said in a press release. The process at each airport will be different, and the agency is working with private companies to offer online pay-

ment options. Now, more than 94% of passengers already have a REAL ID, TSA said. It expects increased wait times for those without.

3 teenagers charged with capital murder in Phenix City death

Three 15-year-olds have been arrested and charged with capital murder (robbery) in Wednesday's shooting death of a Phenix City man, according to the Phenix City Police Department.

Police said officers found Joseph Tassoni, 43, dead at the scene on Cricket Drive from apparent gunshot wounds.

The PCPD Criminal Investigations Division responded and began an investigation, according to the news release.

The PCPD Special Response Team, the Russell County Sheriff's Office STAR team and the Lee County SWAT team executed multiple residential search warrants Saturday, leading to the arrests of the three juveniles, the news release says.

Police said the juveniles are being held in a youth detention center.

How to watch 1st documentary about Columbus native McCullers

The first documentary film about Columbus native Carson McCullers debuted this week, and there's a streaming option for those who missed it.

Georgia Public Broadcasting was scheduled to air "Wunderkind Carson McCullers" in its U.S. television premiere Dec. 1 at 9 p.m.

Born with the name Lula Carson Smith in 1917, McCullers was a bestselling novelist, perhaps most known for "The Heart is Lonely Hunter," published when she was 23. She also was a poet, playwright, essayist and short-story writer.

McCullers suffered through a series of cerebral strokes, partially paralyzing her left side. She died from her final stroke in Nyack, New York, at the age of

According to Vimeo, "Wunderkind Carson McCullers" is a 54-minute documentary by German filmmaker Claudia Muller that "aims to bring to light the work of the best-known unknown in American litera-

The success of "The Heart is a Lonely Hunter" made McCullers "the star of the New York literary scene and a celebrated
