'People are hurting right now'

Iowa City rallies for health care access ahead of ACA Senate vote

Community members gathered near UI Health Care's main campus in Iowa City Thursday, Dec. 11 to rally against cuts to the Affordable Care Act.

The rally, hosted by SEIU Healthcare Minnesota and Iowa, Iowa Citizens for Community Improvement Action Fund, and Johnson County Supervisor Mandi Remington, shared the sentiment that Iowans deserve continued access to affordable health care.

"We're here today to demand that Congress extend health care subsidies for working Americans," said Katie Biechler, political organizing director for Iowa Citizens for Community Improvement Action Fund. "We want them, we need them to extend health care with a clean three-year extension. People are hurting right now, there's an affordability crisis on our hands."

The rally was held just hours before the U.S. Senate rejected a bill to extend ACA subsidies.

Pedestrians centered in new concept

Priorities guide project's conceptual design plan

Iowa City moved forward with a proposed design for the Burlington Street Bridge project that would revamp a century-old roadway that sees tens of thousands of drivers a week and reshape the long-held dam.

Construction for the Burlington Street Bridge Replacement Project is not expected to begin for several more years, but the Iowa City City Council approved a design concept for the project on Tuesday, Dec. 9. A 2021 study found that the bridge was in "poor" condition and was "structurally deficient."

The project will center around updates to the bridge and dam, but includes several broader changes that will transform Grand Avenue and portions of the University of Iowa's west campus. The Iowa Department of Transportation intends to take ownership of the bridge at this point in negotiations, staff said.

The location includes a combination of different interested parties. The southern, eastbound bridge is owned by the city and was first opened in 1915. The northern, westbound bridge was opened in 1969 and is owned by the

Iowa may spend \$1 billion more than it takes in

Republican officials say shortfall part of a plan

Iowa is expected to collect more money next year than this year, but state revenue will still fall nearly a billion dollars short of what the state is spending this year.

A forecast from Iowa's three-member

Thursday, Dec. 11, predicts Iowa will take in \$8.5 billion in fiscal year 2027, which begins July 1, 2026.

Gov. Kim Reynolds must use Thursday's estimate when she submits her proposed budget to the Iowa Legislature in January.

By law, Iowa cannot spend more than 99% of available revenue. For fiscal year 2027, that includes the \$8.5 billion the state is anticipated to collect as well as Iowa's ending balance — the money expected to be left over when the current fiscal year concludes — which sits at \$1.9 billion.
