Lewiston veteran to hold key national VFW post

Douglas Welch named National Surgeon General

A Lewiston man has been elected as the National Surgeon General of the Veterans of Foreign Wars of the U.S.

Retired U.S. Navy Capt. Douglas Welch, 72, was elected to the one-

general, I advise the commander on any kind of medical issues," Welch said during a phone call from Columbus on Thursday.

By "medical issues," Welch doesn't mean direct patient care. He means keeping an eye on the politics affecting veterans.

For instance, Welch said he will continue with a 20-year-old effort to persuade Congress to pass the Richard Star Act, which gives some disabled veterans full retirement pay and full Veterans's Administration benefits.

He is also keeping an eye out in his own backyard where funding was derailed a few years ago for expanding the Lewiston-based Idaho State Veteran's Home.

"Even though it's a state veterans' home, they get a lot of funding from the federal level," said Welch. Welch brings 41

Fire crews battling the Snake River Fire burning near Weissenfels Ridge about 10 miles south of Asotin were feeling good about their progress Thursday evening.

The blaze that is believed to have been accidentally started by someone mowing grass burned about 95 acres in steep country between the river and farm fields northeast of Anatone.

"The south and north flanks on the river side are getting pretty well taken care of," said Chad Sanford, chief of the Blue Mountain Fire District.

He said the fire raced through range land but had not reached wheat fields at the top of the ridge. Weissenfels Ridge Road was

closed during the fire.

crews would be able to
control the fire as long
as the wind stayed calm.
"I think we will be

"I think we will be cold trailing it into the evening," he said early Thursday evening.

Sanford's crew took the lead in suppression efforts and was assisted

by the Asotin County Fire District, U.S. Forest Service, city of Asotin, Washington Department of Natural Resources, and two helicopters and two single-engine air tankers from the state of Washington.

The fire started near the river at about 3:30 p.m. in an area outside

of a fire district but burned onto the area patrolled by the Blue Mountain District.

This marks a second day of busy fire activity in the region, with crews responding to several blazes Wednesday in the region.
