New Turning Point chapters surge across Indiana

Kirk's assassination spurs new requests

TERRE HAUTE - Andrew Bowen had toyed with the idea of starting a Turning Point USA chapter when he enrolled as a freshman this year at Vincennes University.

But that idea turned into a burning conviction on Sept. 10 when he watched a bullet strike and kill Charlie Kirk, founder of the right-wing

political nonprofit, during a debating session with students at Utah Valley University.

The 31-year-old was an outspoken Christian conservative and a key ally of President Donald Trump, helping him make inroads with college students that aided in his election last year.

Police say the assassination was carried out by Tyler James Robinson, a 22-year-old college dropout who prosecutors say was politically motivated to kill Kirk.

University, allowing the club to hold events and meetings on campus.

Within an hour of official status approval, more than 30 students had signed up to join, according to

Bowen, the chapter president.

"We're on a liberal campus, so it wasn't surprising to know that there was going to be people that would push against us," he said. "It was actually even more surprising to know that there was that many people that wanted us to be here.'

'A GROUNDSWELL'

Similar stories are playing out across the state as grief and outrage over Kirk's assassination has led to a surge of new Turning Point chapters at colleges and high schools.

Judge temporarily blocks the Trump administration from firing workers

SAN FRANCISCO — A federal judge on Wednesday temporarily blocked President Donald Trump's administration from firing workers during the government shutdown, saying the cuts appeared to be politically motivated and were being carried out without much thought.

U.S. District Judge Susan Illston in San Francisco repeatedly pressed the assistant U.S. attorney to explain the administration's rationale for the more than 4,100 layoff notices that started going out Friday even though furloughed workers can not access their work emails and there are no human resources specialists to assist with next steps.

"It's very much ready, fire, aim on most of these programs, and it has a human cost," she said. "It's a human cost that cannot be tolerated."

She granted a temporary restraining order blocking the job cuts, saving she believed the evidence would ultimately show the cuts were illegal and in excess of authority.

Asked for comment, the White House referred The Associated Press to the Office of Management and Budget. The budget office did not immediately respond to a request for comment.

The American Federation of Government Employees and other federal labor unions had asked Illston to block the administration

Stellantis to invest \$10M into Kokomo

Facility will produce an all-new engine

Stellantis says it will invest \$13 billion over the next four years to expand its manufacturing capacity in the United States, a move that the automaker says will increase its domestic vehicle production by 50% and add more than 5,000 jobs.

The world's fourth-largest carmaker said Tuesday the investment will support the introduction of five new vehicles, including a Dodge Durango to be built in Detroit and a midsize truck to be assembled in Toledo, Ohio. The new jobs will be spread across plants in Illinois, Ohio, Michigan and Indiana.

Kokomo should see \$10 million of that investment as the facilities here will produce the all-new GMET4 EVO engine.

Production on the GMET4 EVO engine is expected to begin next year. The investment, which will add more than 100 jobs, was initially announced in January.

UAW heralded the announcement as a victory for workers in the Mid-

"A year ago, Stellantis was on a fast-track to moving their U.S. operations out of the country. Their decision today proves that targeted auto tariffs can, in fact, bring back thousands of good union jobs to the U.S.," UAW President Shawn Fain said in a statement. "Wall Street and supposed industry experts said this was impossible. But race to the bottom created by free trade is finally coming to an end."

Stellantis, which was created 41/2 years ago from the merger of Fiat Chrysler and PSA Peugeot, is hoping to counteract some of the expected 1.5 billion-euro (\$1.7 billion) cost of tariffs this year on cars produced in Canada and Mexico by boosting North American profitability with new model launches like the discontinued Jeep Cherokee.

The new product launches will be in addition to 19 "refreshed" products
