IDF CMDR. LT.-COL. A:

'If there is terror financing, we will seize it, wherever it is'

Anywhere there is terror financing in the West Bank, the IDF will seize it, even if it is in the Palestinian Authority's capital, Ramallah, Lt.-Col. A, the IDF's 668th Ram Battalion commander, told The Jerusalem Post in an exclusive interview just after his unit busted Hamas's last banks in Ramallah on Wednesday.

Pressed on whether he was concerned about entering the PA's capital, where the IDF operates much less frequently, he responded, "If there is terror financing, I will in one of its central and most get there. There is no hesitation."

A's battalion was the one with "the most central role for penetrating the bank, seizing the terror funds and equipment, and arresting the Hamas-affiliated individuals close up," he told the *Post*.

Other battalions that were part of the brigade-level operation maintained external security around the bank to allow A's unit to accomplish its mission, he said, giving the other units credit.

Describing the operation, A said, "We entered Ramallah well-known public plazas in order to seize the remaining sources of Hamas's terrorist funds from two bank branch-

"Aspects of the terror financing were entrenched in local funds, whereas others were embedded in foreign currencies. We shut it all down, seizing all of the funds dedicated to terrorism there, as well as related computers, surveillance cameras, and those involved," he said.

While the IDF noted five individuals were arrested, A alluded to there being addi-

He stated that his forces were in Ramallah for the operation for only a few hours.

According to A, he and his forces, along with related ones, had prepared and rehearsed aspects of the operation for several days before carrying it out.

While such operation rehearsals occur with special forces on targeted missions, it is a sign of how complex and unique the mission was that regular infantry were involved in such extensive

US expects Gaza war to end by 2026, 'one way or another'

Trump to chair meeting on 'day after'

US envoy Steve Witkoff said on Tuesday that President Donald Trump was to chair "a large meeting" on Gaza at the White House on Wednesday.

Asked if there is a "day after" plan for Gaza, Witkoff told Fox News' Bret Baier: "Yes, we've got a large meeting in the White House tomorrow, chaired by the president, and it's a very comprehensive plan we're putting together on the next day."

When asked why he was optimistic about reaching a hostage and ceasefire deal,

administration expects the conflict to end by 2026.

"We think we're going to settle this one way or another," he said.

"Hamas is signaling that they're open to a settlement. The Israelis, when they announced this operation, also announced that they were funding \$600 million of aid to go into Gaza, and in addition, that they were open to continuing discussions with Hamas.'

Witkoff added that the Trump administration suggested to Hamas that a good

Witkoff stated that the Trump start to begin negotiations would be to pay more attention to the hostages.

"We've suggested, by the way, that Hamas can begin by feeding the hostages, by giving them medical attention, letting the Red Cross come in, by doing the humane thing,' he said. "The president is a humanitarian; that is what he wants to see.'

Earlier, Witkoff reportedly told Trump that "they talk about you a lot in Hostages Square," during a cabinet meeting.

"I wish I had a camera to show you," Witkoff said.

E3 states moving to reinstate snapback sanctions on Iran

The United Kingdom, France, and Germany are planning to initiate a process on Thursday to reinstate UN sanctions against Iran through their snapback mechanism, European officials told The Jerusalem Post on Wednesday.

Once announced, a 30-day grace period will be in effect, during which the mechanism can be halted. If it is not stopped, all the sanctions that were originally imposed on Iran in 2015 will be reinstated.

Zamir delays Oct. 7 follow-up report after fight with PM

IDF chief also in dispute with State Comptroller

Following a major fallout with Prime Minister Benjamin Netanyahu and Defense Minister Israel Katz over the next stage of the war in Gaza and over IDF appointments, IDF Chief of Staff Lt.-Gen. Eyal Zamir, on Wednesday, took the highly controversial measure of delaying the publication of his follow-up report to the October 7 probes, which were approved by his predecessor, Herzi

Zamir's decision is nearly a complete reversal of his earlier position that it was crucial to rush out specific judgments on the conduct of specific IDF commanders on October 7 in order to lift the cloud still hanging over the military. The IDF chief had been critical of Halevi's probe for not assigning responsibility to commanders and merely describing the failures of the IDF as an institution.

To further his approach, Zamir had ordered Maj.-Gen. (res.) Sami Turgeman to produce a report providing evidence of personal responsibility on the part of certain commanders for the failures of October 7 within mere

The IDF's announcement on Wednesday only said that the report's publication needed to be delayed due to the next steps in the Israel-Hamas War, which may include an invasion of Gaza City, something which Zamir opposes but that Netanyahu has ordered him to carry out.

The chief of staff is against the invasion, saying it will achieve little and could seriously endanger the remaining 20 living hostages held by Hamas.

Netanyahu wants to go ahead with the invasion to

Why has Israel failed to stop the Houthis?

Israel has failed to stop the Yemeni Houthis from firing ballistic missiles and drones at it since October 19, 2023, because of a mix of failed strategy and capabilities, The Jerusalem Post has learned. From October 2023 until July 2024, when a Houthi drone killed an Israeli civilian in Tel Aviv, Jerusalem's approach was to avoid directly confronting the Houthis and to try to leave any fighting with them to the US.

Top Israeli officials - with US officials agreeing with them - during the early stages of the war told the Post that
