# **Fees & documents**

Here are the new rates for Lawrence's rec centers for Lawrence residents and those who live outside of Lawrence. Youth under 17 who live in Douglas County get in free, but they still have to be registered and provide proof of residency Month | Year

Adult resident	\$12	\$120
Adult nonresident	\$15	\$150
Senior (60+) resident	\$8	\$80
Senior (60+) nonresident	\$10	\$100
Household residents	\$20	\$200
Household nonresidents	\$24	\$240

To get the resident rate, you have to provide proof of residency upon your first visit to the rec center. The following documents will be accepted as proof of residency:

- Driver's license or state ID
- Vehicle registration Deed or mortgage document
- Homeowners insurance policy
- Property tax statement Lease or dorm agreement

## Jury finds man guilty of rape, criminal sodomy

Douglas County jurors on Wednesday found a 33-year-old Lawrence man guilty of rape and aggravated criminal sodomy — in a case where they had to determine whether the woman's silent conduct amounted to consent and whether she had been overcome by fear.

A jury took about four hours to determine that Miquel Brown was guilty of the two felonies stemming from an Oct. 27, 2024, incident involving an 18-year-old. The teen said he assaulted her on his living room couch, where she was spending the night after an evening out with the man and his girlfriend.

Brown displayed little discernible reaction as Judge Sally Pokorny read the verdicts. The victim, holding hands with her supporters, looked on quietly from the gallery.

Defense attorney Gary West asked for the jurors to be polled, prompting seven men and five women to each separately stand and affirm that their vote was for "guilty."

All testimony in the trial agreed that the 2024 encounter began with the man sitting beside the teen on the couch and massaging her legs the teen said it began with her feet at an earlier hearing, but at trial she said it started suddenly at her thigh. The touching then progressed to the man undressing her and touching her genital area with his fingers and mouth.

The woman said intercourse occurred. Brown said it had not.

## Courtney and Polian won races in every corner of Lawrence

ome news and notes from Tuesday's local elections in Lawrence and Douglas County:

A big takeaway in the

Lawrence City Commission race is that voters were of one mind about two people.

You used to hear of how Lawrence had an east-west divide on local, political matters. There were no signs of that this year. Newcomer candidates Mike Courtney and Kristine Polian were the big winners, finishing No. 1 and No. 2 on

Tuesday. A look at voting results broken down by precinct shows they were big winners in every corner of the community.

Every precinct in Lawrence – except one — was won either by Courtney or Polian. In other words, there were no signs of a scenario where the other two candidates — incumbent Bart Littlejohn and former

commissioner Bob Schumm — did really well in eastern Lawrence but got overwhelmed by the more populous western Lawrence.

Of the 53 Lawrence precincts, Courtney won 31, Polian won 21 and Schumm won a single precinct. (If you are scoring at home, the one precinct that didn't go for

either Courtney or Polian was Precinct No. 2, which includes parts of Old West Lawrence and includes the area just west of downtown between Sixth and Eighth streets.)

In sum, it was a pretty broadbased geographic victory for the two winners. While the east/west divide has been a real thing in some Lawrence elections, it wasn't this time.
