



Healthy Heartland Motorsports Park could spark tourism in Topeka

New property acquisitions and developments are creating fresh opportunities for tourism and economic growth in Topeka.

The International Hot Rod Association (IHRA) announced the acquisition of the former Heartland Motorsports Park on Dec. 30, The Capital-Journal previously reported.

The acquisition comes at a pivotal moment in Topeka's tourism strategy, said Sean Dixon, president of Visit Topeka and senior vice president of the Greater Topeka Partnership.

It follows a year of substantial infrastructure investments, he said, including the expansion of the Kansas Children's Discovery Center, renovations at multiple cultural institutions, and the
