

# 11 proposals for courthouse

### Existing site or strip club spot suggested

A pair of Boston-based developers are proposing two sites for a new Springfield courthouse, one at a closed strip club and the other at the spot where the existing hall of justice

Chuck Irving, principal with The O'Brien, chief executive officer of the HYM Investment Group, submitted one proposal with those two options to the state to replace the troubled Roderick L. Ireland Courthouse. Their second plan includes the former Mardi Gras strip club.

The announcement came Thursday, just as officials for the state Division of Capital Asset Management and Maintenance released a complete list of prospective developers

### 2 development groups have submitted more than 1 project

Developers propose building the region's new courthouse at sites throughout downtown -including Steiger Park, the location of a closed strip club, on Maple Street where two mostly vacant office buildings sit and next to the MGM casino.

The state Division of Capital Asset Management and Maintenance on Thursday released the addresses and names of developers interested in building a new hall of justice to replace the troubled Roderick L. Ireland Courthouse.

While state officials said there were a total of 10 projects submitted, developer HYM Investment Group and partner Davenport Companies turned in two alternative locations, bringing the total of proposals to 11.

Mayor Domenic J. Sarno said he was happy to see the level of competition for the estimated \$2 billion project. The new courthouse will replace the 1970s-era building at 50 State St.

The state Board of Asset Management agreed in January to fast track the project by having a private developer construct a 220,000- to 300,000-square foot courthouse to its specifications and lease it for 40 to 60 years.

There were initial concerns that few proposals would be submitted, especially with business mogul Peter A. Picknelly talking about a mixed-use development on the Connecticut River waterfront that would include a courthouse. Sarno said he was pleased that was proven incorrect.

# Everyone's mining closets, jewelry boxes

### Customers flock to WMass gold dealers

They've mined closets and jewelry boxes, gathering up coins, chains, charm bracelets and items handed down from mothers and grandmothers.

With gold and silver prices hitting all-time highs, some residents in the Pioneer Valley have decided to cash in.

This month, gold began commanding a price of more than \$4,000 an ounce. And while the price of gold dropped from a high on Monday of more than \$4,300 a troy ounce, many of those who deal in precious metals say the hype is boosting

About 25 years ago, gold cost less than \$300 an ounce. Now, the price far exceeds what some paid 10-15 years ago for, say, a piece of jewelry.

"They're not surprised — they're shocked when they come in," Michael Sarkis, president of Springfield Jewelry and Diamond Exchange, said of people looking to sell their items. It can be a six- or seven-fold increase in price.

"Personally, I think it's going to go higher," Sarkis said. "But you never know."

While the exchange has seen a lot of people looking to cash in by selling, others want to invest,

due to concerns about the state of the economy, he said. Gold is seen as a way to insulate against "hard economic times," Sarkis said, and globally there has been a high volume of trading.

A big factor? The Trump administration's efforts to impose tariffs on goods coming into

the United States to encourage a resurgence of manufacturing.

"I don't think the tariffs are going away anytime soon," Sarkis said.

David Rosen, a team member at The Gold Trader in Springfield, said business has been brisk, with the interest in selling and buying influenced by headlines proclaiming recent moves in the metal's price.

The decision to sell, however, is a personal one, Rosen said. People may be trying to bring an investment to fruition, or may not want to keep precious metal in their house.

"It used to be very, very easy to determine when gold was going to go up," Rosen said, "if there was some sort of an international crisis or something crazy happened in the marketplace."

Now, other factors appear to be influencing the price, including market momentum, he said.

The price for gold surged in recent months. For instance, warehouse retailer Costco made headlines after it began selling gold bars in October 2023, moving hundreds of millions of dollars' worth of the metal.

"If you jumped on the Costco bandwagon a year and a half ago, you did great," Rosen said. But when people come to him asking for his advice on investing in gold, Rosen said he tells them to first consult a financial advisor and to buy with an eye to holding the metal long-term.
