Tom's Cove Visitor Center set for demolition in January

The building, which has housed Na-Assateague Island National Sea- tional Park Service Interpretive, Education and Lifeguard Operations for decades, is scheduled for demolition in early January 2026, according Assateague Island National Seashore.

> In their announcement Assateague officials said the Tom's Cove building

was never designed to be a visitor center, and has been moved twice in its history. "The building is past its useful life and closure will lead to significant savings in maintenance and utility costs," the statement said.

All Park Service staff and programs will move to United States Fish and Wildlife's Herbert H. Bateman Educational And Administrative Center, which will become a joint op-

The popular dessert franchise has secured a lease in the north Salisbury shopping center The Commons, at 2717 North Salisbury Blvd., in Suite D. This is the brand's first location on Maryland's Eastern Shore, and a sign on the door said the location will open Dec. 4, 2025.

The dessert franchise is best known for its weekly rotating menu of cookie flavors. The national flavors listed for the week of Nov. 17-22 are:

Timing uncertain for release of Epstein files

Law gives DOJ 30 days; some info can be withheld

President Donald Trump announced that he signed a bill on Nov. 19 that compels the Justice Department to release all files linked to the disgraced financier and indicted sex trafficker Jeffrey Ep-

Trump made the announcement, claiming that the growing demand for transparency on Epstein's relationships

with the rich and powerful, including the president himself, was the "latest Hoax" created by Democrats. He pointed to high-profile Democrats connected to Epstein, including former President Bill Clinton and former Treasury Secretary Larry Summers.

A pair of lawmakers, Reps. Ro Khanna, D-California, and Thomas Massie, R-Kentucky, championed the legislation as Trump's initial opposition to the bill drew backlash from members of his own party, most notably Rep. Marjorie Taylor Greene, R-Georgia.

By a vote of 427-1, the House passed the Epstein Files Transparency Act. The Senate followed suit when Minority Leader Chuck Schumer, D-New York, introduced a motion for unanimous consent

It is uncertain when exactly the Justice Department will release materials.

The department has 30 days to publicize "all unclassified records, documents, communications, and investigative materials" from the investigation into Epstein, according to the legislation. The files must be released to the public in a "searchable and downloadable format."
