SJ approves DDA TIF, development plan

30-year program to fund downtown improvements

ST. JOSEPH — The St. Joseph City Commission finalized its approval of the Downtown Development Authority's tax increment financing and development plan.

A first reading of the plan was reviewed last month, and a second reading was approved unanimously Monday night.

"The DDA has prepared this over the last few years, working on the TIF to get it through," St. Joseph Downtown Development Director Kelly Ewalt said. amendment lays out several key components of the plan: it updates the list of development projects, adjusts timelines and estimates costs, and shows the TIF capture schedule."

With this approval, a baseline rate for tax collection can be set and incremental growth will be captured starting in 2026.

In short, these changes ensure the plan continues to respond to the community's needs, today's economic conditions and our long-term goals for downtown revitalization," Ewalt said.

The DDA TIF and development plan is intended to use the gradual growth in property tax revenue within the downtown district to make improvements to the same

Because property values typically increase about 2 percent per year, incremental growth will stay with the DDA. This is accomplished by setting a baseline rate for tax revenue, which will continue to be distributed to taxing authorities like the city, library

and Lake Michigan College. **Funds** generated

Groups sue to block Palisades plant reopening

COVERT Environmental groups opposed to the reopening of Palisades Nuclear Plant in Covert Township have filed a federal lawsuit seeking to block the plant owner's moves to resume generating nuclear power there.

The groups – Beyond Nuclear, Don't Waste Michigan and Michigan Safe Energy Future - say the U.S. Nuclear Regulatory Commission violated the Atomic Energy Act by granting Palisades owner Holtec exemptions that would allow the

tion at Palisades even though the to affiliate Holtec International, NRC had previously approved its former owner's request to close and decommission the plant.

"When those certifications were provided in connection with the decommissioning of a reactor, they legally prohibited any further operation of the Palisades reactor or replacement of the fuel into the Palisades reactor vessel," the groups said in their lawsuit.

The groups filed their complaint against the NRC and Holtec Decommissioning International, the company that purchased Palisades

company to resume power produc- in 2022 and transferred ownership which aims to restart the plant. They filed the suit Monday in U.S. District Court for the Western District of Michigan and asked the court to block the NRC's approvals of exemptions that will allow Palisades to resume generating power.

"Holtec's hiding behind decommissioning phase regulatory relief and waivers, and NRC compliantly allowing and enabling it, has resulted in serious, negative safety consequences, which could lead to
