U.S. forces hit Islamic State in Nigeria

Trump says terrorist group targets Christians

President Donald Trump said on Dec. 25 that the U.S. military had attacked Islamic State targets in Nigeria, claiming the group had been targeting Christians.


In a post on Truth Social, the president said he directed the military to launch a "powerful and deadly strike against ISIS Terrorist Scum in Northwest Nigeria, who have been targeting and viciously killing, primarily, innocent Christians, at levels not seen for many years, and even Centuries!"

In a post on X, the U.S. military's Africa Command confirmed it had conducted a strike that killed multiple militants at the request of Nigerian authorities. The strike occurred in "Soboto state," the post said, an apparent reference to the country's Sokoto state.

A U.S. defense official said the strike targeted multiple militants at known camps of the Islamic State group. A video posted by the Pentagon showed at least one projectile launched from a warship.

"I have previously warned these Terrorists that if they did not stop the slaughtering of Christians, there would be hell to pay, and tonight, there was," Trump continued, adding that the Pentagon conducted "numerous perfect" strikes against Islamic State targets in the region.

Sherrill taps adjutant general and **VA nominees**

Two more potential Cabinet members for the incoming Sherrill administration were announced on Dec. 22.

Gov.-elect Mikie Sherrill will nominate U.S. Air Force Brig. Gen. Yvonne Mays to remain in her post as adjutant general of New Jersey and lead the Department of Military Affairs.

Sherrill also intends to nominate U.S. Army veteran Vincent Solomeno III to serve as commissioner of the Department of Veterans Affairs. He currently serves as a deputy commissioner and the state's administrator of veterans affairs.

The Legislature opted to split the New Jersey Department of Military and Veterans Affairs into two separate agencies. That division is effective in January.

Judge rejects Parsippany mayor's election loss challenge

A third and seemingly final attempt by Parsippany Mayor James Barberio to overturn his narrow election loss last month has been dismissed by a Superior Court Judge in Morristown.

Judge Noah Franzblau rejected the Republican's challenge on Dec. 23 with prejudice, meaning it cannot be resubmitted. In a 25-page ruling, Franzblau month by Morris County Assignment said Barberio's claims of voting irregularities were based on "information and belief" without documented evidence.

The ruling sets the stage for Pulkit Desai to be sworn in as mayor in Morris County's largest town in early January and for Democrats to claim both the mayor's seat and a council majority for the first time in decades.

Barberio's two previous court requests for recounts were denied last

Judge Stuart Minkowitz. Initial election night returns showed Barberio ahead by 209 votes in his bid for a fourth term as mayor. But after counting late-arriving mail-in and provisional ballots, Desai was certified as the winner by 80 votes.

The mayor's latest challenge, Franzblau wrote, included "neither a certification nor affidavit from any of the 155
