Lawmakers, Trump officials join in tribute at Kennedy Center

WASHINGTON - Trump administration officials, Republican lawmakers and other supporters gathered at the Kennedy Center in Washington, DC, on Sept. 14 to pay tribute to conservative commentator Charlie Kirk, who was fatally shot last week at a Utah college campus.

More than an hour before the prayer vigil was scheduled to begin, a line of attendees behind a red velvet rope extended out the door and around the building. Some attendees sported "Make America Great Again" hats and T-shirts with slogans.

A line of police vehicles was also parked on the drive up to the Kennedy Center, Washington's iconic theater that overlooks the Potomac River. Thousands of people packed into a large theater at the venue, as some stood singing and raising their hands while a trio played a Christian song to kick off the ceremony.

The vigil was open to the public "due to an overwhelming outpouring of support from supporters" of Kirk, according to a news release from

U.S., China reach TikTok framework agreement

Trump, Xi to confirm deal in Sept. 19 phone call

The United States and China reached a framework agreement to switch short-video app TikTok to U.S.-controlled ownership that will be confirmed in a call between President Donald Trump and Chinese President Xi Jinping on Sept. 19, U.S. officials said

Trump had hinted that a deal has been reached to resolve issues over Tik-Tok's China-based ownership, days before the next ban deadline for the social media app.

"A deal was also reached on a 'certain' company that young people in our Country very much wanted to save. They will be very happy!" Trump wrote in a Truth Social the morning of Sept. 15.

Some government officials have raised concerns that TikTok, which is owned by Beijing-based company ByteDance, poses a national security threat because of possible data sharing
