Session starts with drama

Film tax credit bill narrowly survives a challenge in Legislature

CARSON CITY — A special session of the Nevada Legislature started with dramatics Thursday that challenged a blockbuster bill

to lure Hollywood studios to Southern Nevada and followed with hours of legislative hearings on more than a half dozen other proposals.

During the initial reading in the Assembly of a bill proposing increased tax breaks for the film industry,

Assemblymember Selena La Rue Hatch, D-Reno, invoked a rule that can be used to force a vote on whether a bill should be rejected from further consideration. An absent lawmaker was teleconferenced in for the vote, and a 21-21 tie allowed the

measure to move forward. Republican Gov. Joe Lombardo called a special session of the Legislature on

Wednesday, saying the state needed to address more than a dozen pieces of leg-

Boring Co. pays fine for illegal dumping

Elon Musk's Boring Co. was fined nearly \$500,000 for illegally dumping apparent drill fluid into the Clark **County Water Reclamation** District's sewer system, according to documents

reviewed by the Las Vegas Review-Journal.

The reclamation district said in an Aug. 14 cease and desist letter to Boring Co. that district inspectors carried out an on-site inspection on Aug. 13 following an anonymous tip and observed active illicit

discharge of what appeared to be drilling fluid via two direct connections into onsite cleanouts at the site of a future Vegas Loop station at 3824 Paradise Road, the former site of the Firefly tapas restaurant.

F1, LVCVA eye future of race deal

A longer-term deal to keep the Formula One Las Vegas Grand Prix in Southern Nevada into the next decade is being eyed by race and area officials as the 2025 edition approaches.

The initial three-year deal between the Las Vegas Convention and Visitors Authority and F1 ends after this year's race, set for Nov. 20-22, with a new twoyear deal kicking in after that. Officials hope to ink a new deal, which could keep the race in Las Vegas for several years, following the
