Permit filed for a south Reno Costco

A permit was filed Monday with the city of Reno for a Costco Wholesale store in south Reno.

The pre-planning application permit lists an address of 14450 S. Virginia St., on the corner of South Virginia Street and Geiger Grade Road, east of Shayden Summit Reno mall.

The permit includes construction of a “large retail establishment,” a gas station and car wash on

161,553 square feet of land.

The project is part of a development by Pioneer Parkway Holdings Co. LLC, which is part of a larger development by Lewis Holdings LLC, according to the permit.

South Reno residents have long been wanting — or dreading — the construction of a Costco store in the area. The closest Costco is on Harvard Way off Plumb Lane, about eight miles away.

Comey pleads not guilty to charges

Defense seems likely to seek case’s dismissal

WASHINGTON – Former FBI Director James Comey sat stone-faced and staring straight ahead as the nation’s one-time lead law enforcement officer appeared before a federal judge Oct. 8 as a criminal defendant in a case with monumental significance.

The proceedings in northern Virginia were routine enough. Over the course of a few minutes, lawyers for the 64-year old Comey entered pleas of not guilty to a pair of federal charges that their client lied to Congress and obstructed a congressional proceeding in testimony he gave more than five years ago about his investigation into 2016 election interference. Comey was released on his own recognizance pending a trial scheduled for Jan. 5, 2026.

But the underlying case has major ramifications. President Donald Trump has pushed the bounds of the Justice Department’s historic independence from the White House in publicly calling for Comey to be prosecuted. The case has raised concerns about a president using the justice system against his adversaries.

Comey’s lawyer Patrick Fitzgerald, a former senior Justice Department official, outlined a robust defense. He told the court that he would introduce motions to dismiss the case on the grounds of selective and vindictive prosecution, abuse of the grand jury process and outrageous conduct, and is seeking to have Lindsey Halligan disqualified because she was not properly seated before she took the case before a grand jury.

Halligan has handled the case since Trump installed her to replace Erik Siebert, a longtime federal prosecutor who either resigned or was fired as the U.S. attorney for the Eastern District of Virginia after he reportedly raised concerns about whether there was enough evidence to go after Comey. Halligan was the only prosecutor to sign off on

Musician, attorney identified as crash victims

The Reno couple who were hit by a car Saturday, Oct. 4 while cycling on U.S. 395 Alternate near Pagni Lane in Pleasant Valley have been identified by colleagues as Susan and Rew Goodenow of Reno.

Susan Goodenow died at the scene and her husband, Rew Goodenow, was taken to a hospital, Nevada State Police said.

Rew Goodenow is an attorney with Parsons Behle & Latimer and served as

president of the State Bar of Nevada in 2006-07.

Susan Goodenow’s Facebook profile shows she and her husband were avid cyclists and outdoors enthusiasts. She was involved in Reno’s music community and served as an accompanist for Bella Voce choral group.

According to her bio on the Bella Voce website, she earned a bachelor’s of science from the University of Iowa and a master’s in choral conducting from the University of Nevada, Reno. She was a co-founder of the Sierra Nevada Children’s Choir and served as the artistic director for the Bel Canto, Vivace & So-

noro choirs and conducted the Concert Choir and Women’s Choir at UNR.

“The State Bar of Nevada offers its sincere sympathies to former bar President Rew Goodenow on the loss of his wife Susan, and support for his recovery,” the State Bar of Nevada said. “Rew has offered decades of service to the Nevada bar, not only in leadership and governance, but also as general counsel and as a subject matter expert author.”

Troopers said the driver stayed at the scene and cooperated with investigators. No charges have been announced.
