Another corrections officer pleads guilty in Nantwi case

Another corrections officer involved in the Messiah Nantwi case has plead guilty and could face up to four years in federal prison.

Nantwi, an inmate at Mid-State Correctional Facility, was brutally beaten to death on March 1 by a Correction Emer-

gency Response Team to the point of unresponsiveness and beaten twice more, with his hands cuffed behind his back. After the fact, the grand jury alleges corrections officers met together to plant evidence and submit false testi-

Daniel Burger stood before Judge Michael Nolan on Aug. 14 and had been scheduled for oral arguments, however in the time since his last appearance and now, he accepted a plea deal and pleaded guilty to offering a false instrument for file.

Burger had been charged with firstdegree manslaughter, first-degree gang assault, second-degree gang assault, fifth-degree conspiracy, and first-degree offering a false instrument for fil-

Oneida, Bishop Grimes high schools both unsafe

Oneida High School students have lost their school twice this summer, both times because the buildings simply weren't safe enough.

Attorney for CO argues crime scene definitions

Corrections officers in the Messiah Nantwi were back before Judge Michael Nolan on August 14, and for one of the COs attorney, he argued for dismissal of charges.

Nantwi, an inmate at Mid-State Correctional Facility, was brutally beaten to death on March 1 by a Correction Emergency Response Team to the point of unresponsiveness and beaten twice more, with his hands cuffed behind his back. After the fact, the grand jury alleges corrections officers met together to plant evidence and submit false testimony.

Donald Slawson is charged with tampering with physical evidence after allegedly mopping up blood and cleaning the infirmary in which Nantwi was beaten. He was back in court before Judge Nolan on Aug. 14.

Slawson's attorney, Kevin Luibrand, argued that Slawson had not intent to tamper with evidence and that the grand jury indictment didn't allege that.

"The factual evidence is that [Slawson] mopped up a room," Luibrand said. "All the grand jury indictment says is that [Slawson], preventing an analysis of blood. It doesn't have the required element of intent or that it would be used [in the investigation.]"

"It wasn't declared a crime scene five hours later, when originally it wasn't. Senior officials at the jail went through the area and none of them declared it a crime scene. And it wasn't Slawson's obligation to declare it a crime scene."

Police: Bystander ends shooting by hitting alleged shooter

A bystander ended a shooting in Herkimer on the night of Aug. 14 by hitting the alleged shooter with his car, according to a Facebook post by Herkimer Police Chief Mike Jory.

One male shooting victim and the alleged shooter were both taken to Wynn Hospital in Utica, where both were listed in stable condition at 3:30 a.m. the next morning, the chief said.

Herkimer officers were first dispatched to the area around the Herkimer Burger King around 10:40 p.m. on Thursday, Aug 14, Jory said. More information then came in indicating the incident might have actually taken place on the 100 block of North Main St., he

Officers then noticed several people standing near the Endzone Pub & Grub at 129 North Main St. and a vehicle parked diagonally in front of the pub, heading in the wrong direction. They

found a male standing near the vehicle, who had been shot, and another male lying on the ground in front of the vehicle, who turned out to be the alleged shooter, Jory said.

That's when officers were told that a bystander had used his vehicle to stop the shooter, "most likely preventing
