GLENS FALLS - A new fine dining establishment, Katy's Wine and Whiskey Bar, will be the first of several key businesses that will take part in South Street's revitalization. The business will be located on the ground floor of the newly renovated 46 South Street on the corner of South and Elm streets.

### Former GF police member arrested after alleged theft of PBA funds

GLENS FALLS - A former member of the Glens Falls Police Department was arrested Tuesday after allegedly taking more than \$5,000 from the PBA.

The Glens Falls Police Benevolent Association's former treasurer, John Hogan III, was arrested December 2. The arrest came after an internal review found that Hogan allegedly withdrew funds and failed to make required deposits totaling more than \$5,000.

The PBA reported that because the dollar amount constituted a felony charge, the case was referred to New York State Police and the Saratoga County District Attorney's Office to help ensure a full independent criminal investigation could be conducted.

Hogan was arrested by New York State Police. According to court documents obtained by The Post-Star Thursday, some charges in Hogan's case are sealed, but according to the available public documents, he pleaded guilty to the violation of disorderly conduct, and was fined \$150. Any other charges and additional sentences in this case were sealed according to the court documents.

"This is a profound betrayal of trust," a statement from the PBA read. "Anyone who engages in this conduct has no place in a position of trust or law enforcement. The PBA acted immediately to remove John Hogan III from all financial responsibilities to prevent further mishandling of union funds."

The PBA's review began immediately after irregularities were identified within financial accounts, the PBA reported Wednesday.

"The PBA takes criminal behavior seriously and maintains the principal that no one is above the law, including our own members," a statement from the PBA read. "In this case, the union and its members were the victims, and we took every action within our power to hold John Hogan III accountable and pursue prosecution to the fullest extent of the law."

Hogan is believed to have acted alone in the alleged incidents, the PBA and the Glens Falls Police Department reported.
