## Developer still plans 405 apartments at Dixie Cup factory

Officials denied the tax break proposal, but the developer maintains the site will see new apartments despite the setback.

Developer Brian Bartee of Skyline Investment Group is reportedly moving forward with plans to redevelop the former Dixie Cup factory in Wilson Borough into 405 apartments despite losing a key tax incentive.

The \$160 million project sought local approvals for Tax Increment Financing, or TIF, which would have allowed local taxing bodies to delay increasing the property's assessed value for a set number of years. The resulting tax revenue from the higher assessment would have been used to pay off bonds issued for construction.

Wilson Borough Council and the Wilson Area School District approved the TIF proposal. Northampton County Council voted it down in early November.

Bartee described the outcome as disappointing but said the development will proceed.

"This was not an unexpected result," he said, according to a report earlier this month in Lehigh Valley Business. "I had a plan for this. It's not going to slow us down. It's too important for too many people."

He indicated to the business news organization he may seek TIF support again next year, noting that the three county council members who opposed the measure did not win re-election.

County council members cited several reasons for rejecting the plan at their meeting in early November. They raised concerns about granting tax breaks to a developer while the county faces budget **SEE APARTMENTS, A3**

## 1 of 5 charged in basketball court slaying sentenced

City man, 20, gets decades in prison after pleading guilty to third-degree murder, conspiracy in 2024 shooting.

One of five people charged in a fatal shooting on an Allentown basketball court has been sentenced to state prison, according to a news release from Lehigh County District Attorney Gavin Holihan's office.

Angel Martinez-Velez, 25, of Allentown, was shot numerous times while playing basketball June 1, 2024, at Fountain Park on Martin Luther King Jr. Drive.

Carlos Landesta-Agramonte, 20, also of Allentown, pleaded guilty in September to third-degree murder and conspiracy. Lehigh County Common Pleas Court Judge Thomas Caffrey on Tuesday sentenced Landesta-Agramonte to serve 20 to 40 years in prison.
