# Palmyra liquor license site hits county sale list

A Lebanon County judge has denied the appeal of a controversial liquor license transfer in Palmyra, with the property now scheduled to be sold in a county upset sale on Sept. 8.

On July 28, Lebanon County Court of Common Pleas Judge Charles Jones denied Just Wing It founder Chris Behney’s appeal of Palmyra Borough Council’s rejection of the transfer of a liquor license owned by Ninkovich LLC to 1

East Main Street. The license was last used at The Samler Taphouse on 800 Cumberland St., which closed in June 2018 after five years in business.

Council members at the Feb. 13, 2024 hearing cited that Behney being delinquent and/or late paying sewer, refuse and tax accounts was one of the reasons they denied the license transfer, which is something Behney’s lawyers claimed was grounds for an appeal.

In his ruling, Jones said that the council did not abuse its discretion by considering Behney’s history of failing to pay taxes when denying the transfer.

“Applicant’s history of delinquent or unpaid utilities bills and taxes is clearly related to the conclusion that allowing the License transfer would be detrimental to the community: A property or business owner that cannot or will not remit timely payment for taxes and utility services can only have a negative impact on his community,” Jones wrote in his decision.

This is the second time Behney was involved in moving the license to 1 East Main Street. Behney is the brother of

# Paranormal investigator died of heart issues

Almost two months after his unexpected passing drew international attention, the cause of death for a famed paranormal investigator in a Gettysburg hotel was announced by the Adams County Coroner’s Office.

An autopsy found that Dan Rivera, 54, the lead investigator for the New England Society for Psychic Research and a U.S. Army veteran, passed away of natural causes on Sunday, July 13, 2025 as a result of heart issues.

“Mr. Rivera had a known history of cardiac issues, which were consistent with the findings,” said Adams County Coroner Francis Dutrow in a release issued on Thursday, Sept. 4, 2025.

“We extend our condolences to Mr. Rivera’s family and loved ones during this difficult time,” Dutrow said.

Rivera was among the leading faces of the viral “Devils on the Run Tour,” in which Rivera and other members of the New England Society for Psychic Research had brought the allegedly haunted doll, Annabelle, across the country to various sites.

The Gettysburg leg of the tour, which was hosted by Ghostly Images of Gettysburg Tours at the Soldiers National Orphanage, completely sold out, organizers said, selling over 1,260 tickets across three days on the weekend of Friday, July 11, 2025, with the visit concluding on Sunday afternoon.

Rivera had briefly attended the Annabelle event on Sunday, July 13, but had returned alone to his hotel room on Presidential Circle in Straban Township after complaining of chest

NAPLES, FL – It’s a start and long overdue, according to people who work in dementia care, regarding a Medicare benefit of \$2,500 to help diagnosed individuals and their caregivers.

What comes next is appreciation for the Centers for Medicare and Medicaid Services, which established the benefit that families can use for respite, or

breaks, from caregiving.

Health care professionals see how families struggle. They know respite is essential for family members who are bone tired, anxious and feel adrift in need of a lifeline of support on all fronts, including financially.

“Without access to respite, caregivers frequently neglect their own health,” said Christine LoConte, executive director of The Dubin Center, an
