Senior living hub sale finalizes

Pleasant View Communities purchases Mount Joy Country Homes for \$11.4 million

Pleasant View Communities has purchased the 55plus Mount Joy Country Homes retirement community for \$11,440,000, finalizing a plan first announced earlier this year.

The deed transfer was recorded last week.

Mount Joy Country Homes, formerly part of Messiah Lifeways, has 80 independent living cottages on 31 acres. Around 120 residents live there.

"The (Mount Joy Country Homes) cottages are not

included in the continuum of care at Pleasant View but offer another option for seniors looking to downsize and to be free of property maintenance," according to an announcement of the deal by Pleasant View. "The community features an on-campus library, fitness studio, community room, support services, and a resident-led calendar of activities."

SDL raises police presence at schools

Amid increased online attention over teacher's social media post on Kirk killing

The School District of Lancaster said it is working with police to protect students and staff following a "strong public reaction" to a teacher's post on social media about Wednesday's fatal shooting of influential conservative activist Charlie Kirk.

Lancaster city spokesperson Stacia Korman confirmed in an email Friday morning that the police department's officers "are working directly with the schools to ensure the safety of the students and staff."

In an email sent to district families Thursday evening, Superintendent Keith Miles

condemned violence of any kind and maintained that the district would not be publicly sharing details on any personnel matters related to the post.

"We want to reassure you that we are working closely with law enforcement to ensure the safety of our students and staff and they are confident that it is safe for all students to attend school tomorrow," Miles said. "We expect business as usual in the district on Friday."

Judge rules Ahn unable to stand trial

Man charged in double homicide deemed incompetent, to be taken to health facility

A man previously charged with abusing his mother's corpse in Lancaster County is incompetent to stand trial for a double homicide in Maryland, a judge ruled.

Kevin Hyun Ahn, 31, will be transferred to the Maryland Department of Health, where he will be involuntarily committed following Baltimore County Judge Judith Ensor's ruling.

Ensor determined the Schuvlkill County man can't stand trial for the murders of Sun Tok Lim, 83, and Lim's ex-husband, Yong Kim, 69, both of Maryland.

Charging documents in the double homicide case say Ahn also killed his 61-year-

old mother,

has not been charged in her death as of Friday.

The Lancaster County District Attorney's Office dropped the abuse of corpse charge when the Baltimore County District Court charged Kevin Ahn with two counts of first-degree murder and two counts of assault in April for the deaths of Lim and Kim.
