County Budget OK'd

Department Heads Ordered To Cut Their Individual Budgets By 10%

After a 10% across-the-board cut was defeated, the Yankton County Commission unanimously voted Tuesday to cut operational budgets by 10% for next year.

With the action, the commissioners finalized their 2026 budget ahead of the Oct. 1 deadline under state law.

Commission Chairman John Marquardt said the 10% cut in operational costs, which he supported, would reduce the 2026 budget by \$1,232,470.

However, the decision wasn't made before a heated discussion among the commissioners and between some commissioners and the county officials now tasked with cutting their

departments' operations.

During the discussion, Interim Emergency
Medical Services (EMS) Director Troy Cowman offered to remain as the head of the ambulance and related services on a permanent

"I have been in the interim position, off and on, for seven years," he said, adding the current search for an EMS director has already lasted five months.

Cowman estimated, to bring in a new director from the outside, would require an additional \$100,000 for a competitive salary that

"Giving While You're Living" was the mantra behind a $\$250{,}000$ donation to the River City Domestic Violence Center (RCDVC) Tuesday morning.

Longtime Yankton resident Diane Reese, along with her son, Mike Huether, announced the donation during an open house and tour of the newly renovated shelter and family exchange

Cassie Nagel, executive director of RCDVC, said the gift came at a time when they needed it most.

"When I stepped into leadership, our board and staff worked together to set a clear vision," she said. "We identified three major goals: strengthen sustainability so we can serve clients effectively and retain the incredible staff who walk alongside survivors every day; educate our community about healthy relaionships and the role we all play in our services to meet the needs of clients and communities who often face barriers to care before and after the crisis has passed. Diane's gift became the catalyst to put those goals into motion.

"The irony was that while we were doubling our shelter capacity with this addition, cuts to our federal VOCA (Victims of Crimes Act federal funding) grants meant we were wrestling

Pillen Adds \$20 Million To Nebraska **Property Tax Relief Funds**

LINCOLN, Neb. — Nebraska Gov. Jim Pillen this week directed about \$20 million in unused higher-than-expected casino revenues to instead be distributed

Pillen, in an executive order Monday, said the state had more casino gambling



revenue and unused money in two property tax relief funds than lawmakers had anticipated when they passed the state's latest two-year budget in May. Pillen

ordered Nebraska Property Tax Administrator Sarah Scott to distribute the full increased amounts as she allocates tax credits in the coming months.

'Whenever possible, we must get bureaucracy out of the way and ensure that Nebraskans receive the full amount of property tax relief possible," Pillen said in a Tuesday statement announcing the order. "This is a commonsense, good government measure that will help Nebraska families across the state.

The combined result means an additional \$77 million state investment in tax credits to offset local property taxes compared to last year, according to the state

The executive order states that "recent events, increasing revenues, appropriation limitations and transfer timing" meant certain funds had been retained and were not being disbursed in the manner that would "produce the maximum property tax relief" for taxpayers.

Before the additional \$20 million, the legislatively allocated total in the Property Tax Credit Cash Fund, with credits allocated to counties as a portion of statewide valuations, was \$422 million. Total state funding in
