Short-term rental enforcement to get better, marshal says

The City Marshal's Office this week got access to contact information for people responsible for short-term rental properties so it can reach them to issue citations and warnings, the city said.

Before that, the office lacked access to a database of contact information for owners, managers and a 24/7 on-call designee required by city rules.

Because of that lack of information, deputy marshals often could issues warnings or citations only by mailing them to the rental home, City Marshal Heather Morris said.

Having access to the contact information will change the game in terms of the office's response to complaints about ordinance violations at short-term rentals, Morris said.

That would be an improvement in one of the sorest of sore spots among islanders who are fed up with excessive noise, illegal parking and trash violations at short-term rentals and argue

the city's enforcement of its own rules has been lax.

The office's priority is to compel rental operators to comply with the rules, rather than issue citations, so notifying of violations is important, Morris said.
