No Increase

VISD Board adopts 2025-2026 budget and tax rate

he Victoria Independent School District (VISD) Board of Trustees adopted the district's 2025-2026 budget and tax rate on Thursday at a special meeting. The Board adopted a balanced budget and approved a no-increase tax rate. The approved rate maintains the lowest combined tax rate in over 30 years.

The Board of Trustees adopted a total budget of \$159,024,974 for the 2025-2026 year. The budget is composed of three areas: Maintenance and Operations (M&O), Child Nutrition and Interest and Sinking (I&S).

The Board budgeted \$139,045,858 for M&O, \$9,904,916 for Child Nutrition and \$10,074,200 for I&S. Over 80 percent of the budgeted M&O funds are applied to payroll. Additional maintenance needs resulting from unexpected situations, such as emergency facility repairs and bus replacement, will be covered by the district's fund balance. The district is required to maintain at least 75 days of operating costs for natural disasters and emergencies.

The Board approved a total tax rate of \$0.8035 per \$100 of taxable value. The approved tax rate is the same as the previous year, maintaining the district's lowest combined rate in more than three decades, according to the VISD Notice

Boelter then proceeded to shoot and wound State Senator John Hoffman and his wife at their home. Both Representative Hortman and Senator Hoffman were Democrats.

Both men were obviously disturbed and deranged.
