# Person struck by fire truck

A Bridgewater fire truck was struck on Oct. 30 while responding to a crash on Interstate 81 in Rockingham County, resulting in one person being seriously injured, Virginia State Police said.

Shortly after midnight, state police initially responded to the 238 mile marker on I-81 in the northbound lanes after a tractor-trailer that had jackknifed was hit by a second rig, a press release said. Both vehicles came to rest in the median.


The driver of the second tractortrailer was taken to an area hospital with minor injuries. The driver of the jackknifed tractor-trailer was charged with reckless driving.

Police said a Bridgewater Volunteer Fire Company fire truck responded to the crash with its emergency equipment activated. As the fire truck slowed, it was struck from behind by a 2018 Ford sedan. The driver of the sedan suffered serious injuries and was hospitalized, police said. A passenger was also injured. No injuries were reported on the fire truck.

The crashes remain under investigation.

### Augusta woman convicted of two financial felonies

A Grottoes woman has been convicted on two felony charges in a case where prosecutors said she illegally acquired hundreds of thousands of dollars in cash from a longtime friend.

The victim, Mary S. Hatton, who later died, was suffering from cognitive decline when she gave power of attorney to her friend, 72-year-old Bonnie S. Williams, according to evidence. Williams took control of her finances, withdrew large amounts of cash, had Hatton's Grottoes home put in her own name and bought another residence in Rockingham County with Hatton's money.

Following a four-day trial in Augusta County Circuit Court, on Oct. 24 a jury found Williams guilty on charges of financial exploitation of a mentally incapacitated adult and financial exploitation of a vulnerable adult.

#### Money missing, property changes

Following the death of her husband in a farming accident in 2019, Hatton, based on court records, inherited more

than \$2 million. But evidence showed she was experiencing a decline in her mental health and that her condition grew progressively worse in 2021 and

In 2021, Williams, who'd know Hatton for a number of years, moved into a home about a mile away from her on Payne Run Road in Grottoes. That same year, evidence showed that one of Hatton's stepchildren was given power of attorney over her finances.

However, when Hatton, who had a habit of moving large sums of money from one bank account to another, agreed to a conservatorship and guardianship appointment, she forgot about the discussion, according to Augusta County Deputy Commonwealth's Attorney Alexandra Meador. When one of her stepchildren paid for the services, the payment overdrew Hatton's bank account after she'd once again shifted her funds. Meador said the mixup led Hatton to falsely believe somebody was trying to steal her money. Hatton then nixed her initial POA and in early 2022 she made Williams her power of attor-

In 2022, there were several large
