## Portage County Health Care Center sold for \$2.7M

STEVENS POINT – After decades of discussion and debate, the Portage County Board on Dec. 16 voted to approve a resolution to sell its nearly 95-year-old skilled nursing facility.

The County Board approved on a 15-10 vote Tuesday night the asset purchase agreement and the operations transfer agreement for the sale and transfer of the Portage County Health Care Center at 825 Whiting Ave. in Stevens Point to Galena Healthcare LLC and Timms Hill Health Holdings LLC, both subsidiaries of California-based The Ensign Group Inc.

Portage County will receive \$2.7 million for the sale of its skilled nursing

home from Timms Hill Health Holdings LLC, a Nevada-based company. Timms Hill will then lease the property to Galena Healthcare LLC, another Nevada-based company.

The purchase agreement also requires Ensign or its subsidiaries to invest at least \$1.3 million into renovations of the skilled nursing facility within the first two years of ownership.

#### 'Now is not the time to sell'

Seven county residents spoke against the sale at Tuesday night's meeting, calling for the board to wait one more year or until a new county executive and several new County Board members are elected in April.

"Now is not the time to sell," John Bertelson, of Plover, told the board.

Others brought up voter-approved referendums in 2018 and 2022 that provided funds for operational expenses for the health care center as well as a new \$20 million facility, and a promised third referendum on the November 2024 ballot that never happened.

"I believe our Board of Supervisors was mistaken not to provide the public another referendum to ascertain the citizens' wishes regarding maintaining [the Portage County Health Care Center]," stated Mildred Neville, of Stevens Point.

And others expressed their concern about what the future holds once a privately-owned company takes over operations of the county-owned facility.
